Specific parameters for the implementation of the HPtuners brand elements.

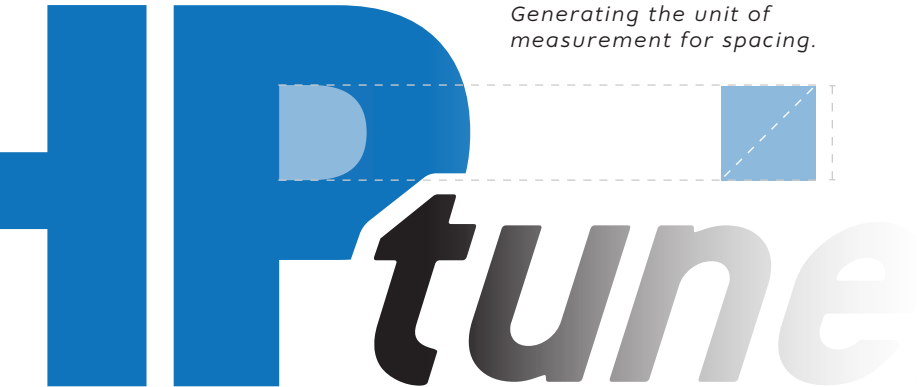

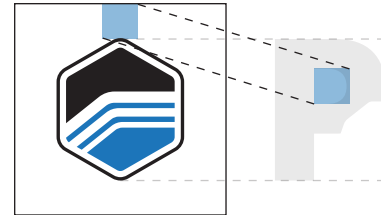
SPACING

Minimum spacing around the HPtuners logo and other HPt brand elements must be at least the size of the hole in the "P" as demonstrated in figure 1a.

The HPt logo found in figure 1b requires equidistant top and bottom spacing from the "P" as created by the minimum spacing from the edge of the bottom of the "t."

SCALING AND ALTERATIONS

Lots of focus has been given to the size, spacing, and placement of the logo components. As such, the HPtuners logo is not to be dimensionally altered or disassembled in any way.

COLOR PALETTE

The HPtuners brand palette is comprised of three primary colors: HPT Blue, Black, and White. These colors are complimented by two specific shades of gray.

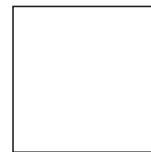

COLOR COMBINATIONS contd.

Some exceptions can be made using the monochromatic logo options to accommodate different brand colors.

Each color has a respective tint on the grayscale. When using monochromatic logos, ensure you are using the correct color within the approved grayscale range for optimal application.

**Black not above 85% tint*

***White not below 30% tint*

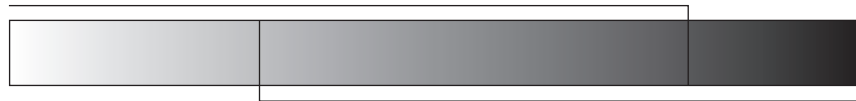

PATTERNS and GRADIENTS

To retain a modern look and logo clarity and legibility, do not place the logo above a pattern, gradient, or high-contrast background image.

To distinguish HPTuners as a modern, technical company with a clean aesthetic and focus on clarity and simplification, the Supra font family has been approved for print and digital use.

SUPRA BOLD: *abcdefghijklmnopqrstuvxyz*
HEADERS AND TITLES SHOULD BE CREATED USING UPPER CASE SUPRA BOLD WITH NO PUNCTUATION

SUPRA LIGHT ITALIC: abcdefghijklmnopqrstuvxyz
Subheaders should follow using Supra Light Italic in blue sentence case with full punctuation.

SUPRA LIGHT: abcdefghijklmnopqrstuvxyz
Content paragraphs should follow using Supra Thin in sentence case with full punctuation.

NOTE: If character spacing options are available, set to 100.

SUPPLEMENTAL BRAND ELEMENTS

EMBLEM

Sometimes a full logo is not needed, but having branding is still important. We have created the HPTuners Emblem to satisfy those circumstances.

The emblem is a unique derivation of the space between the “P” and the “t” in the HPTuners logo. This shape has been multiplied and expanded to imitate tracer lines like found on an ECU board.

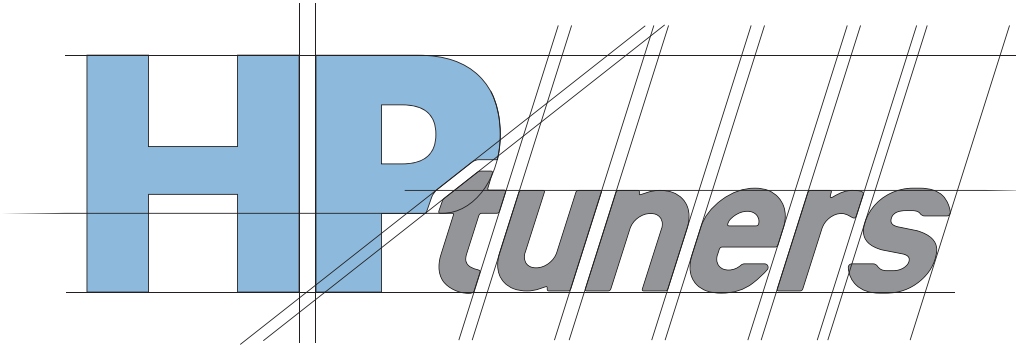


CIRCUIT LINES
